## October is Firewood Month!

**Firewood Month's** two overarching goals are; raise public awareness about firewood movement as a forest pest and disease pathway, and encourage people to incorporate their most easily accepted safer firewood buying and/or gathering behaviors for recreational or home heating needs. Each year, there are established theme weeks throughout October to organize best practices based on situations and audiences, but these themes are flexible to your needs, and all participants are encouraged to celebrate Firewood Month in whatever way works best for your outreach audience.

**The first week in 2020, October 4-10th, is themed **General Firewood Information**** (from the forest pest pathway perspective) and by coincidence it is also **Fire Prevention Week as designated by the National Fire Protection Association**. Great timing! You can weave both themes together, or just talk about forest pests- whatever you think will work best.

## Comment now on the status of a blight-resistant American Chestnut

The American chestnut was an incredibly ecologically and economically important tree species in North American forests until the catastrophic accidental introduction of an invasive forest pathogen- chestnut blight- in the early 1900s. One recent effort to create and plant blight-resistant

trees is now in the comment phase; the Petition for Determination of Nonregulated Status for Blight-Resistant Darling 58 American Chestnut. Learn more about this process and petition, and make your voice heard, on the Federal Register. Comment is due by October 19th 2020.

## **Federal Quarantine on Pine Shoot Beetle will end November 2, 2020**

The pine shoot beetle, a non-native invasive forest pest affecting North American pines, will no longer be a federally regulated pest after November 2nd, 2020. This change will affect the legality of moving some types of pine products both between states, and between the USA and Canada- including pine firewood.
