Plan for Tree Check Month in August

The Asian longhorned beetle has several remarkable look-alike species in North America, with the various and widespread pine sawyers in the genus Monochamus being among the most likely to be mistaken for an Asian longhorned beetle. In northern states like New York and Massachusetts, the adult Asian longhorned beetles emerge in late summer, while the lookalike adult native Monochamus tend to emerge several months earlier. So it is no wonder that Tree Check Month is in August each year- encouraging the public to check their trees for these big showy beetles and the signs of their presence, while minimizing mistaken identity for native insects in their northern range! Infestations and Regulations

Nearing 10 years of GALS

In September 2011, USDA APHIS confirmed an infestation of giant African land snail (GALS, or sometimes giant African snail, GAS)- kicking off a decade of delimitation, quarantine, control, management, and one-by-one removal of distinct quarantined zones. Of the 28 total known infested zones in the greater Miami area, only five remain on the map at this time. It's worth noting that the prior infestation (discovered in 1966) took ten years to eradicate- but it was successful in the end. Not all forest pests that can be transported in or on firewood are beetles or moths- and in some cases, a methodical eradication effort can succeed in even the most complex of urban environments.
