Emerald ash borer found in Moorhead, Minnesota

Emerald ash borer (EAB) has been confirmed just 2 miles from the border of North Dakota - a state with more than 90 million ash trees in forests and where ash makes up 20-80% of urban trees. North Dakota Department of Agriculture does maintain a quarantine on EAB. NOT moving firewood in this region is more important than ever to slow the spread of this highly destructive pest.
