It's been a decade since Michigan first launched Emerald Ash Borer (EAB) Awareness Week to focus attention on the destructive, ash-killing beetle and the risks associated with moving firewood. Now numerous federal and state agencies, non-government organizations, campgrounds and recreational areas are taking up the charge! US Forest Service Announces Extensive Campground Messaging

The U.S. Department of Agriculture, Forest Service's Firewood Taskforce has just completed a widespread effort to prevent campground visitors across the nation from moving firewood. Informational messages have been established on 2,100 Forest Service campground websites within the two online reservation systems used by the federal government, Recreation.gov and ReserveAmerica.com. These messages are on each campsite description online and will be printed on the confirmation receipts that campers must take.

Additionally, the Forest Service has dispersed posters strategically throughout locations with high visitor traffic in recent years and is revisiting those efforts in locations where additional poster deployments are needed.
