## KEY TO ABBREVIATIONS

ALB = Asian longhorned beetle

E = Eradicated- used for eradicated Asian longhorned beetle

EAB = Emerald ash borer

Ext Q = External Quarantine, regulated material (i.e. firewood) is not allowed INTO a Ext Q area without state and/or federal heat treatment certification

Fed Q = Federal Quarantine, regulated material (i.e. firewood) is not allowed OUT OF a Fed Q area without federal heat treatment certification

GM = European gypsy moth

IFA = imported fire ant, also called: imported red fire ant or red imported fire ant (RIFA)

LW = Laurel Wilt

TCD = Thousand cankers disease of walnut

reg = Regulation

rec = Recommendation, i.e. generalized outreach statement- existing with or without a regulation to back it

Q = quarantine, used as in- State Quarantine, Federal Quarantine, or External Quarantine

X = Row currently applies to this state

X<sup>1</sup> = CDFA's approach to external quarantines is to address each pest separately, but this ends up approaching a full Exterior Quarantine when considered as a whole (5 forest pests + IFA)

X<sup>2</sup> = Minnesota has a full external quarantine on all hardwood species, but not softwood/coniferous

X<sup>3</sup> = Oregon prohibits untreated firewood from all sources outside of the Pacific Northwest (OR, ID, WA)

X<sup>4</sup> = Ohio and Wisconsin TCD area external quarantines apply to all species of firewood

\* = Note that External Quarantines typically do permit the entry of state and/or federally certified packaged heat treated firewood

## KEY TO REGIONALLY IMPORTANT PESTS: notes on invasive species that may be moved on firewood and are found in single states or are of regional concern

Arizona contains native populations of goldspotted oak borer

California has invasive infestations of: goldspotted oak borer, polyphagous shot hole borer, and sudden oak death

Florida has an infestation of giant African land snail

Hawaii is generally infested with giant African land snail

Michigan has an infestation of eastern heath snail

Minnesota is concerned about mountain pine beetle, which is native to and widespread in north central and north western states (including MT, WY, CO, and others)

Montana has an infestation of eastern heath snail

Oregon has an infestation of sudden oak death

Pennsylvania has an infestation of spotted lanternfly

Texas has an infestation of Mexican soapberry borer
